

Marquette County Specific Tax Implementation Committee Meeting January 30, 1979

The meeting was called to order by Chairperson Clayton Anderson at 7:25 p.m.

Members present were: Clayton Anderson, Henry Schneider, Don Potvin, Jim Sodergren, Wes Larson and Sally May.

Members absent were: Harry Miron, Bill Smith and Pat Farrell.

In attendance were: Peter Empley, Peter Brown, Jamie Nazie (WLUC-TV), and Denise Roth (Sterio 100).

A motion to approve the minutes of the December 27, 1978 meeting was made by Wes Larson supported by Henry Schneider, and carried.

Chairperson Anderson explained that the purpose of the meeting was to discuss the first draft of the Committee's report to the County Board of Commissioners. The draft report had been mailed to all committee members several days in advance of the meeting.

There was considerable discussion about the title of the report and it was agreed by consensus the title should be "Summary Report of the Specific Tax Implementation Committee to the Marquette County Board of Commissioners".

There was considerable discussion regarding the content of the report. Don Potvin made numerous suggestions for corrections and additions, and both Don Potvin and Sally May requested that a reference be made to the original Study Committee and how that committee was formed. It was agreed to include that as a footnote to the report with an additional note that the Study Committee's report is on file. Comments from other committee members were received with the additions and deletions being made.

It was moved by Wes Larson, supported by Jim Sodergrer and carried to accept the amended report.

It was moved by Wes Larson, supported by Henry Schneider and carried that the record show a note of appreciation to Jim Sodergren for his contribution in serving as Co-ordinator of the committee.

A motion to pay Peter Brown the \$250.00 as per agreement was made by Jim Sodergren, supported by Wes Larson and carried.

Clayton Anderson thanked members of the committee for their contribution and efforts in trying to make the Specific Ore Tax more equitable.

It was the consensus of the committee members that the County Board should consider setting up a committee to further monitor and make recommendations relative to mineral resources in Marquette County.

Motion to adjourn was made at 9:10 p.m.

SPECIFIC TAX IMPLEMENTATION COMMITTEE MEETING

Wednesday, December 27, 1978 5 p.m.

The meeting was called to order by Chairman Clayton Anderson at 5:10 p.m.

Members present were: Chairman Clayton Anderson, Don Potvin, James Sodergren, John Farrell, Henry Schneider, and Sally May.

Members absent were: Harry Miron, William Smith and Wesley Larson.

It was moved by James Sodergren seconded by Don Potvin that the minutes be approved of the meeting of December 5, 1978.

James Sodergren stated the budget has \$419.00 and it seems all outstanding bills have been paid.

Mr. Sodergren reviewed the status and the purpose for which the Marquette County Specific Tax Implementation Committee was intended. After considerable discussion it was the consensus of the members present that a final report be prepared and presented to the Marquette County Board of Commissioners and that copies of the report be placed in various libraries, clerks offices, etc. It was also suggested that Peter Brown be asked to write the report for an amount not to exceed \$250.00. Committee member Sally May suggested that a first draft be sent to committee members for their review prior to a final report.

It was moved by Pat Farrell and supported by Sally May and carried that we contract to have a final report prepared by Peter Brown for \$250.00 and that the report be completed by February 1, 1979.

Sally May gave a report on a meeting with Mary Soper and Peggy . Frazier, Governors aids. Sally feels the response and the meeting was non productive and that they were of no help in getting HB 6725 vetoed.

The committee then took up the matter of a law suit against the DNR and the State Geologist for not _ administering the Specific Tax law properly as indicated by the Auditor Generals report. It was the concensus of the Committee that the Prosecutors office commence legal action but that perhaps this was a matter which this committee has no jurisdiction and should be properly handled by the Marquette County Board of Commissioners.

Chairman Clayton Anderson adjourned the meeting at 5:50 p.m.

SPECIFIC ORE TAX IMPLEMENTATION COMMITTEE MEETING

Monday, November 27, 1978 5:30 p.m.

The meeting was called to order by Chairman Clayton Anderson at 5:30 p.m.

Members present: James F Sodergren, Sally May, Don Potvin, Henry Schneider, & Clayton Anderson.

Members absent: William Smith, Pat Farrell, Harry Miron & Wesley Larson.

The first order of business was approval of the minutes of November 13, 1978. It was moved by Sally May, supported by Henry Schneider and carried unanimously to accept the minutes as presented.

Don Potvin gave a report on the Committee budget. The County Board of Commissioners has transferred out of the budget \$1,500.00 leaving a balance of \$838.00. It was suggested by Sally May that the Committee ask the County Board to reappropriate the \$1,500.00. It was moved by James Sodergren and seconded by Henry Schneider and carried that the report be accepted.

Jim Sodergren gave a report on HB 6725 which has been introduced by Mr. Jacobetti. Jim noted 3 changes and concerns with the bill:

1. Page 2 Lines 4, 5, 6, & 7 should not be deleted: ("Low grade iron ore mining property" means an area of mineral bearing lands estimated to contain sufficient tonnage of available low grade iron ore to maintain capacity operation of beneficiation or treatment plants for a period not exceeding 10 years, together with LAND FROM WHICH LOW GRADE IRON ORE IS MINED, etc.

2. Page 3 Line 3: The rate is reduced from 2% to 1.1%.

3. Page 5 Lines 9 - 23: The tax provided inthis act shall be in lieu of AN advalorem taxes upon the TAX ON ANY OF THE FOLLOWING:

- A. The low grate iron ore, or upon the
- B. THE low grade iron or MINING property, or upon the
- C. THE mining thereof, or the OF THE LOW GRADE IRON ORE MINING PROPERTY.
- D. THE production of <u>concentrates</u> or <u>other merchantable</u> <u>product there from or upon the concentrate or other</u> <u>merchantable product produced</u>, <u>or upon the lands IKCN</u> <u>OKE PELLETS OR OTHER CONCENTRATED OR AGGLOMERATED PRODUCTS</u> FROM IRON ORE PELLETS.
- E. THE IRON ORE PELLETS OR OTHER CONCENTRATED OR AGGLOMERATED MERCHANTABLE PRODUCTS FROM IRON ORE PELLETS.
- F.THE REAL PROPERTY occupied by or used in connection with the mining, <u>quarrying</u>, transportation; and bendficiation or the ore and shipping of <u>a merchantable concentrate or</u> <u>other products therefrom</u> IRON ORE PELLETS OR OTHER CONCENTRATED OR AGGLOMERATED MERCHANTABLE PRODUCTS FROM IRON ORE PELLETS.

The above changes, particularly Section F., needs clarification in regard to the Power Plants in Marquette.

It was moved by Sally May and supported by Henry Schneider and carried that payment of expenses for the trip to Lansing by Anderson, Potvin and Sodergren, on November 21, 1978, be approved.

 Those words underlined are words deleted and which are in the original specific tax law.

SPECIFIC ORE TAX IMPLEMENTATION COMMITTEE MEETING

Monday - November 13, 1978

The meeting was called to order by Chairman Clayton Anderson at 5:30 p.m.

Members present: James Sodergren, Henry Schneider, Sally May, Don Potvin and Clayton Anderson.

Members absent: Pat Farrell, Harry Miron, Wes Larson, and William Smith.

In attendance: Tom Solka from the Prosecuting Attorneys office.

The first order of business was approval of the minutes of September 20, 1978 committee meeting. It was moved by Sally May, supported by Jim Sodergren and carried unanimously to accept the minutes as presented.

A communication was received from Senator Mack thanking the committee for the report on the Specific Ore Tax Hearings held on August 23, 1978.

Sally May will be requesting a report of the August 16th meeting of the Upper Great Lakes Regional Commission Meeting.

Mr. Tom Solka gave a report of the "Interpretation of 10 year proviso of Section 1 (b) of the low grade iron ore tax (MCLA 211.621)". Copies of the report have been distributed to all members of the committee.

Henry Schneider reported to the committee his rational as to the value of the ore bodies which are in excess of 10 years of production. He used the Tilden Mine as an example. It was the concensus of the committee that steps be taken to further investigate the value of known ore reserves and to place them on the advalorem roll.

After discussion it was moved by Don Potvin and supported by Henry Schneider and carried that the committee recommend to the County Board of Commissioners that they request the State Geologist make an appraisal of known or proven ore reserves at the Republic Mine, Tilden Mine, Empire Mine and the Cascade project.

A motion was made by Jim Sodergren and seconded by Sally May and carried that the committee recommend to the County Board of Commissioners that they request from the State Geologist, under the Freedom of Information Act, any and all information regarding the size of the ore bodies together with the drilling records on the Republic, Tilden, Empire, and Cascades properties.

A motion was made by Jim Sodergren and seconded by Don Potvin and carried that the County Board of Commissioners request, under the Freedom of Information Act, from the Auditor General a copy of the Audit which was done by their office in Marquette County. If a final report has not been completed then a request for work sheet data should be made.

It was moved by Sally May, supported by Jim Sodergren that the meeting be adjourned at 6:55 p.m.

Specific Ore Tax Implementation Committee 6 p.m. meeting September 20, 1978

The meeting was called to order by Chairman Clayton Anderson at 6 p.m. Members in attendance were: Sally May, Henry Schneider, Jim Sodergren, Don Potvin, Clayton Anderson and Pat Farrell.

Absent members were: Wesley Larson, Bill Smith and Harry Miron.

Minutes of the last meeting were read by Jim Sodergren. A motion was made by Don Potvin and seconded by Henry Schneider to approve the minutes.

Mr. Sodergren stated there is a balance of \$2,480.01 in the Committee budget.

A report on the local hearing was presented by Mr. Sodergren. Mr. Sodergren presented the members with a first draft summary of the hearing. Corrections and changes were made. The committee decided to send copies of the final summary to: Mr. Jacobettis Iron Ore Legislative Committee, all candidates seeking office, the Governor, County Board members, Specific Ore Tax Committee members, Mr. John Kelley, and the news media.

Mr. Sodergren reported that Mr. Solka has sent a letter to Mr. John Kelley of C.C.I. requesting that he meet with the Prosecutor, Henry Schneider, and Jim Sodergren relative to the interpretation of 211.621 and also the ore body assessment.

Mr. Sodergren reported that the price of pellets has been increased once again from \$37.50 to \$39.00 per ton.

A motion was made by Jim Sodergren, seconded by Pat Farrell to adjourn the meeting, the time being 7 p.m.

Mr. Farrell made a motion to adjourn, seconded by Bill Smith.

PROGRESS REPORT TO THE BOARD FROM THE SPECIFIC TAX IMPLEMENTATION COMMITTEE

Ladies and Gentlemen:

At the March 21, 1978 meeting of your Specific Tax Implementation Committee, it was agreed that the time had come for the Committee to submit a progress report for your information.

BACKGROUND

As you know, our Committee was formed by the Board to implement the recommendation of a previous Specific Tax Study Committee. That Study Committee, representative of various interests within the community, worked for a full year on the question of whether or not the specific tax was equitable as compared to the property tax, for which it is a substitute. The Study Committee concluded and reported to the Board on November 1976, that the Specific Tax is not equitable and that an unfair burden is being placed on the property taxpayer, who is, in effect, subsidizing the mining industry. Their recommendation was that the mining industry should be paying the present 2% rate on the value of the product they are actually shipping (pellets), rather than on the value of old range non-bessemer ore, which is no longer shipped. In addition, they recommended that the rate should be tied to the property tax rate so that, in future, when the property tax rate increases, so will the specific tax rate. They pointed out that while this change would come somewhat short of the mining industry paying their equal share of taxes, it would help to reduce the present inequity. Since the Study Committee's charge was to study the issue only, and not to consider the politics of the matter, their work was finished upon submitting their findings and recommendations.

So, on April 28, 1977, our Committee was formed and charged with the responsibility of convincing the State Legislature to change the specific tax formula according to the Study Committee's recommendations.

STEPS TAKEN TO IMPLEMENT RECOMMENDATION AND PROGRESS TO DATE

Our first step, of course, was to contact our Upper Peninsula State Legislators -particularly Senator Mack and Representative Jacobetti. However, to date, in spite of numerous efforts on our part, they have not consented to meet with us to discuss the matter. We have, however, been able to meet with other legislators and State staff people, including Senator Fitzgerald, Representative Montgomery (Chairperson of the House Taxation Committee), Senators Derenzinski and Anderson, Gerald Miller (Director of the State Office of Management and Budget), and several of the Governor's staff. In virtually all of these discussions it was pointed out to us that Representative Jacobetti could get a change in the tax through the Legislature with little difficulty, if he chose to do so; and conversely, that he could effectively prevent any change if he wished. We know that Representative Jacobetti is opposed to any change -- (he has said so and all of his actions to date tend to bear that out.) Frankly, we cannot understand why he should oppose it, since he has very recently come out protesting the burden placed on the property taxpayer. At any rate, without any help or support from our Upper Peninsula legislators, we felt that it was necessary to generate popular support for the change. With that goal in mind, we have made presentations to various groups and organizations throughout the UP. Some of the following organizations which have gone on record in support of the change:

At the same time, the mining industry has been lobbying hard with our State Legislators and local groups and organizations to gain support for their position that the tax should not be changed. The following organizations have gone on record against any change:

We have been courteously received wherever we have made presentations, except by the State Legislative Committee chaired by Representative Jacobetti. At each of these hearings people testifying in favor of changing the tax were extensively and sometimes rudely questioned and cross-examined. However, those who spoke in support of the mining industry's position for no change were treated courteously and were questioned very little. We had hoped that one of the first hearings would be held in Marquette County, since that is the source of the request for change. However, Representative Jacobetti has said that he does not want to hold a hearing here until all of the members of his Committee can be present and that may not be for some time.

PUBLIC RESPONSE

In the meantime, many Marquette County citizens have become interested in and supportive of the proposed change and have contacted individual committee members with both questions and suggestions. Some of the suggestions were to increase the 2% rate, to give each County Board the authority to set the rate in their county, or to put the mining property back on the property tax. The questions we are frequently asked concern distribution, which as you know was not considered by the Study Committee. Our Committee has discussed distribution however, and feel that the present level distribution should remain unchanged with any additional revenues, as a result of an increase in the tax, perhaps going to the County homeowner in the form of an iron ore tax credit.

We have also received input from the general public on the issue through a question placed on the Property Tax Reform Questionnaire recently sent out by the County Property Tax Reform Committee. We understand that the Property Tax Reform Committee hopes to have results of the questionnaire compiled soon and will report to the Board when that is accomplished.

CONCLUSION

As time passes and nothing is done to change the specific tax, while the property taxpayer's assessments go up year after year, and mining related community needs become more expensive, we are convinced that it is absolutely necessary that we vigorously continue our efforts to convince the State Legislature to change this tax. We are also absolutely convinced that Marquette County citizens should have an opportunity to make their voices heard in a meaningful way on this most important issue. For this reason, we are requesting the Board's permission to hold a number of public hearings throughout Marquette County on this issue. It would be our intent to present the Board's position at the hearings, to receive all comments both for and against the issue, and to carefully record all such comments for transcription. This information could then be provided to you and to our State Legislators. Members of the Committee have indicated their willingness to donate their time to conduct such hearings.

We appreciate this opportunity to report to you and wish that we could report that our task has been completed. However, there is still much work that must be done. We look forward to receiving further direction from you.

Specific Tax Implementation Committee Meeting November 11, 1977 - 2:00 P.M.

Present: Anderson, Schneider, Sodergren, Farrell, Potvin, and May

Absent: Miron, Larson, and Smith

MINUTES

The Minutes of the previous meeting were approved as distributed.

REPORT ON LANSING TRIP

Sodergren and Anderson reported on their trip to Lansing on behalf of the Committee. Senator Fitzgerald's assistant, David Haynes, made all the necessary arrangements for the trip, securing appointments, meeting them at the airport, etc.

Their agenda included a meeting with Representative Anderson to discuss his H.B. 4982 which deals with environmental and taxation issues having to do with mining. Rep. Anderson explained that he has separated the two issues environment and taxation. The taxation portion will be introduced to the House Taxation Committee as soon as possible. Presently that Committee is busy with Single Business Tax matters. He also indicated that he will talk to Jacobetti about the Bill and will suggest that the Bill be included in the hearings Jacobetti has said he will conduct on the mining industry.

Anderson and Sodergren asked Rep. Anderson not to tamper with taxation on underground mining due to the marginal nature of the operations.

Rep. Anderson was apparently not aware that the unions are in favor of increasing the specific tax and asked for copies of the Steelworkers resolution and the letter of support from Linus Wampler. (This has been done).

Senator Anthony Derenzinski was also contacted. While he did not commit himself to an increase in the tax, he said he was convinced that there was inequity and some change was needed. He asked for a map of all lands that would be exempt.

Representative George Montgomery, Chairperson of the House Taxation Committee, was seen but was not at all helpful. The lobbiest for the mining industry was leaving Montgomery's office as Anderson and Sodergren arrived, and Montgomery told them that he is opposed to any change. However, he said that he had asked the lobbiest (Jim Goulette) to go back to the mining industry and come up with something that would be acceptable to them.

A meeting was also held with representatives of the Department of Management and Budget. Those attending were: Robert Kleine, Director of the Office of Revenue and Tax Analysis, Patricia Cole, Special Assistant to Gerald Miller, and Janet Kintzer, State/Local Division Office of Inter-governmental Relations.

Kleine indicated that they had met with mining representatives and that the mining industry was willing to support a change in base but with a porportionate decrease in rate. They emphasized that there were greater costs to produce a ton of pellets in Michigan. This point was debated by Sodergren and Anderson, showing lower costs in Michigan than Minnesota in some important areas. Sodergren also pointed out that the mining industry refused to submit their cost sheets to back up their arguments that costs are higher in Michigan. Sodergren asked if the Governor's from the three states (Michigan, Highesota, and Visconsin) would neet to discuss mining and Cole indicated that she would pose that question to the Governor.

Kleine seemed to keep pressing for a justification of need for the extra revenue an increase in the tax would bring, and didn't seem to be so concerned with the inequity of the tax. Sodergren suggested that if the specific tax could not be increased to achieve equity, then a royalty tax should be imposed. Minutes Continued - Pare 2

Following discussion on the report, it was moved by Potvin, supported by Farrell, that the Committee send a letter of thanks to Senator Fitzgerald for all the help his aide David Haynes provided to the Committee, with a copy of the letter to go to Haynes. The motion carried.

It was then moved by May, supported by Farrell, that the Committee go on record in favor of Anderson's bill. Motion carried. (Copy of Anderson's bill attached to these minutes).

The Committee then discussed information that should be compiled and graphics that should be drawn to assist in presenting the Committee's position. Farrell agreed to color a map to represent lands that are under specific tax, Commercial Forest Reserve lands, State lands, and lands held by NNU and MSU. Farrell and Sodergren will work together on a needs assessment.

COMMUNICATIONS

From: SENATOR RIEGLE, in response to a request for assistance, stating that the matter would ultimately be decided in the State Legislature and that he could provide no assistance at this time, but perhaps at a future date.

DAVE DEROCHE stating that the Iron County Planning Commission has unanimously passed a resolution in support of a change in the specific tax and will make a recommendation to the Iron County Board to do the same.

PAUL GRAVENDONI to the Mining Journal regarding an article that appeared in Business Week, titled "Why Money Flows from Iron Ore". Sodergren indicated that this is a most informative article. (Copy of the article attached to these minutes).

JIM CLANCY to <u>Mining Journal</u> arguing that Minnesota and Michigan cannot be compared and pointing out that Minnesota taxpayers are not benefiting from the tax structure there. After some discussion the Committee decided that it would be better to plan for some paid advertising -- perhaps to appear when Rep. Anderson's bill is being considered -- that will clearly indicate that the Committee's information on Minnesota is correct.

FINANCIAL REPORT

Moved by Potvin and supported by Farrell that the financial report be accepted.

NEW BUSINESS

Because many of the legislators downstate are not aware of the broad support for a change in the specific tax, the Committee decided to send copies of the <u>SUN</u> articles and editorial in support of a change in the specific tax, to the House and Senate Taxation Committees and the Governor.

An invitation was received from the Delta County Board to speak to them on December 6, at 7:30 P.M. Burt Boyum of CCI will also be at the meeting to present the mining industry's side of the specific tax issue. It was acreed that Potvin would go, that Smith would be asked to go. Also, Sodergree will attend and, if possible, Anderson.

Notion by Farrell, supported by Sodergren to send a letter to all those who were contacted on the Lansing trip, thanking them for their time and consideration. Also a letter to Rep. Anderson pledging support of his bill and urging him to call for no change on underground mining taxation. Copies of this letter to be sent to the media as a press release (U.P. wide). Notion carried. Specific Tax Implementation Committee Meeting November 11, 1977 - 2:00 P.M.

Potvin proposed that Anderson be put on per diem by the Committee to press for active endorsement from local unions. Anderson declined.

Specific Tax Implementation Committee Meeting September 30, 1977 - 6:30 P.M.

Present: Miron, Schneider, Sodergren, Anderson and May

The meeting was called to order immediately following a brief discussion with Senator William Fitzgerald. Those in attendance at the meeting with the Senator, besides Committee members were: David Haynes, Assistant to the Senator, and Tom Baldini.

COMMUNICATIONS:

Sodergren presented the following communications for consideration and discussion- - -

- 1. Response from David N. Skillings, Jr., Publisher and Editor, of Skilling's Mining Review to inquiry by Henry Schneider regarding the setting of the price of Old Range Non-Bessemer Ore. According to the communication (a copy attached to these minutes) Cleveland Cliffs Iron Company is the only company to ship this product and therefore sets the price.
- 2. Copy of a letter from Linus Wampler, United Steelworkers District #33 President, to Charles Younglove, United Steelworkers District #29 President, informing him of Wampler's support of a change in the Specific Tax formula and asking for his support of same. Also a follow up letter from Sodergren, on behalf of the Committee, to Younglove regarding the Committee's position and pledge to provide any information, assistance, etc.
- 3. Letter from Sodergren to State Representative Anderson regarding H.B. 4982 expressing concern that this bill will repeal the Specific Tax altogether and explaining that the Committee's position is for <u>no change</u> on underground operations due to the marginal operation of this type of mine. Sent recommendation of Committee but have received no reply as yet.
- 4. Copy of a resolution from the Dickinson County Road Commission to Milliken and others opposing a change in the Specific Tax.
- 5. Letter to the Committee from Osmund Kemp, Recording Secretary of the Marquette County Labor Council, indicating that it would not be possible to provide the Committee with mailing addresses of AFSME locals.
- 6. Copy of a resolution from Baraga County Board of Commissioners in support of a change in the Specific Tax.

NEW BUSINESS:

Sodergren reported that the Committee has received a copy of "Introduction to the Subject of Assessment Valuation of Tatable Iron Mining Properties" and "A Critique of the Michigan System of Iron Ore Mining Property Valuation As It Has Evolved Since 1910". These materials were received from the Iron County Democratic Party. Moved by Sodergren, supported by Schneider to approve \$27.60 be sent to the Iron County Democratic Party to reimburse for the duplicating costs on these materials. Motion carried unanimously.

OLD BUSINESS:

There was some discussion on the advisability of meeting with Representative Anderson and others, if possible, to explain the Committee's position on the Specific Tax. It was moved by Miron, supported by May and unanimously carried, that Sodergren be authorized to set up such a meeting as soon as possible.

Sodergren asked if the Committee should contact the unions now. It was the consensus of the Committee that this should be done and that various materials be sent to them for their information. Specific Tax Implementation Committee September 30, 1977 Page 2

REPORTS:

Anderson reported that the County Board has sent a follow up letter to Representative Jacobetti regarding the proposed hearings on the Specific Tax, since no reply has been received to the Board's first letter of inquiry.

Sodergren reported that he has written to John Pavlovich, Chairperson of the Gogebic Democratic Party, about making a presentation to their group. Mr. Pavlovich phoned in reply saying that he will firm up a day and time for such a presentation as soon as possible.

Anderson informed the Committee that Joe Racine has distributed the Specific Tax Committee's brochures to a number of people in the Gwinn area, and as a result these people have asked to hear a presentation by the Committee. Racine will help to arrange such a meeting at the Committee's request.

There being no further business to come before the Committee, the meeting was adjourned at 7:15 P.M.

In reply to your letter of September 8, I think that perhaps the only producers of Old Range Non-Bessemer ore are the Mather mine of The Cleveland-Cliffs Iron Company and the Sherwood mine of Inland Steel Mining Company.

I believe that most of the Mather ore is purchased by Bethlehem Steel Corporation and, of course, the Sherwood ore is purchased by Inland Steel Company.

In our issue of January 15, the current price of Old Range non-bessemer ore is \$21.43 per gross ton basis, 51.50% iron natural, was established by Cleveland-Cliffs, which is the principal producer.

I hope that the above information is useful.

Request from Sodergren to make 14 copies of all the material to date.

Smith suggested that Committee members contact community members in support of a tax change to speak at the hearings. Mr. Ben Harris, who has had some letters in the Mining Journal, was mentioned.

Sodergren asked that Schneider get information on the distribution of the Salt Tax from the Salt Mines in Wayne County.

Mr. Clark addressed some questions and comments to the Committee and indicated he feels that the mines should be paying a tax on the product actually shipped but has not yet decided the merits of the right of the County Board's position on the Specific Tax.

A motion was made by Anderson, seconded by Smith and carried that the meeting be adjourned.

MINUTES

The meeting was called to order by Anderson. Sodergren made a motion that the minutes of the last meeting be approved. Potvin seconded the motion. The minutes were unanimously approved.

COMMUNICATIONS

Sodergren read a report from Schneider in regard to the assessments on mines in Arizona. Commercial and industrial properties are assessed at 25 percent of value whereas producing mines are assessed at 60 percent.

Sodergren read a letter from Klaryce M. Bilski, Iron County Clerk, in regard to the Iron County Board of Commissioner's meeting of August 9, 1977. The Iron County Board tabled the letter and accompanying brochure from the Marquette County Specific Tax Implementation Committee for further study, and agreed to invite the members of the Committee to the next regular Board Meeting on Tuesday, September 13, 1977 at 1:00 P.M. which will be held at the Iron County Courthouse, Crystal Falls. Anderson, Sodergren, Smith and Potvin will attend the meeting.

Sodergren read a letter from Keith D. Palkki, Recording Secretary, Local Union 2912, USWA saying that this union had adopted the resolution calling for a change in the Specific Tax. It was agreed, after some discussion, that the Committee should publicize the fact that Local Union 2912 has passed the resolution.

Sodergren read a letter from Joe Racine to Rep. Jacobetti asking Jacobetti if he had a report on the Minnesota Tax Program. Mr. Racine had not received an answer as of this date.

Sally May told the Committee of verbal communications:

She had heard from the Iron County Democratic Party that following Sodergren's and Anderson's presentation to them they passed a resolution calling for a change in the Specific Tax formula. Shortly after the Democrat Party had received an invitation from a mining company representative for dinner and drinks to discuss the situation. The dinner was held and the mining representative gave a presentation but the Iron County Demicratic Party did not change their position.

The Goegebic County Democratic Party was very interested in having a member of the Committee speak at one of their meetings. The person to contact is John Pavlovich, a teacher from Goegebic Community College. The Committee said that they would be interested in attending a meeting and would contact Mr. Pavlovich as to when the meeting would be. May told the Committee that Mr. Pavlovich has a copy of the Majority and Minority Reports.

She had heard from the West Iron School Board. The Superintendant of the West Iron County School wrote a letter to Rep. Jacobetti asking that there not be a change in the <u>distribution</u> of the Specific Tax. The West Iron Schools receive \$37,000. a year tax revenue from the Sherwood Mine. This mine will close next August. Dick Pall is in charge of the publicity for the Hanna Mining Company. He and the Specific Tax Committee are invited to attend their next School Board meeting on Tuesday, September 20, 1977 at 5:30 P.M. A motion was made by Smith, seconded by Potvin and carried that the Committee attend. Sodergren, Smith and Potvin will attend.

HEARINGS

There was a general discussion on what the Committee should do to prepare for the upcoming hearings to be scheduled by Rep. Jacobetti. A motion was made by Smith, seconded by Sodergren and carried to have a meeting September 7, 1977 at 1:00 P.M. for the purpose of planning each member's position prior to the public hearings. Discussion was held in regard to the seeming reluctance of some of the news media to print some of the letters to Editor from Sodergren. Further efforts and contacts will be made, if necessary, with various Editors in an effort to get the letters printed.

MEETING WITH GOVERNOR

A motion was made by Smith, seconded by May and carried that the Committee continue efforts to meet with Governor Milliken.

A. G. REPORT

The A. G. Opinion regarding Specific Tax and it's distribution has not been received. Efforts will be made to get the Opinion after which Bill Smith will study and report to the Committee.

UNITED STEEL WORKERS OF AMERICA

Efforts should continue to be made in setting up a meeting with Linus Wampler, President of Steelworkers District 33. Harry Miron will be asked to help in scheduling a meeting with him.

REPRESENTATIVE ANDERSON'S BILL

Sodergren told the Committee of a news article indicating that State Representative Anderson is writing legislation pertaining to the Specific Iron Ore Tax. A motion was made by Potvin, seconded by Farrell and carried that Sodergren first call then write to Rep. Anderson, to determine what sort of legislation he is proposing.

OTHER NEW BUSINESS

Sodergren told the Committee of a meeting he attended at the Nicolet College in Rhinelander, Wisconsin, of the Wisconsin Mineral Resources Association made up primarily of County Commissioners. He was very impressed with Mr. Kreske, a banker from Iron River, who spoke on equity.

OTHER OLD BUSINESS

Potvin told the Committee that he is still interested in a thermometer or graph type form of publicity showing the amount of money lost to government for every day (or week) the Specific Tax remains unchanged. A motion was made by Sodergren, seconded by Potvin and carried that Sodergren and Schneider would work on such a graph that would not require a lot of detailed data and report back to the Committee at the next meeting.

ADJOURN

A motion was made by Sodergren, seconded by Schneider and carried that the meeting be adjourned.

MINUTES

The meeting was called to order by Anderson. Larson made a motion that the minutes of the last meeting be approved. Sodergren seconded the motion. The minutes were unanimously approved.

COMMUNICATIONS

Sodergren informed the committee that the United Steel Workers have requested a speaker for a meeting on July 17, 1977 at 7:00 P.M. Anderson said that he would attend the meeting and speak.

Sodergren received a letter from George Montgomery, Chairman of the Taxation Committee, indicating that the information received relative to the public hearings conducted by Rep. Jacobetti will be considered by his committee.

Sodergren received a letter from Jesse Perry of the United Steel Workers of America requesting a speaker. He told the committee that he will check further with Mr. Perry when the meeting would be.

Sodergren reported a letter received from Rep. Dominic Jacobetti requesting a complete audit of the County's expenditures and receipts.

Sodergren reported on a meeting with Commissioner :oseph O. Racine relative to his discussion with Rep. Dominic Jacobetti. It is Joe's feeling that Rep. Jacobetti is opposed to any increase in the specific tax.

A motion was made by Potvin, seconded by Larson and carried that the committee subscribe to two magazines from Minnesota. Sodergren ordered six-months subscriptions from the Skillings' Mining Review and the Minneapolis Star.

A motion was made by Farrell, Seconded by Larson and carried that Sodergren will look into the possibility of setting up a meeting with Vice President Walter Mondale, Governor William G. Milliken, Governor Perpich (Minnesota), and Linus Wampler, Director of U.S. Steel Workers, on July 27th at the National Association of County's conference in Detroit. OLD BUSINESS

Present: Commissioners Anderson, May, and Potvin, County Treasurer Sodergren, Equalization Director Schneider, Mr. Harry Miron, and Negaunee Township Supervisor Larson.

Absent: Commissioner Farrell, Mr. William Smith.

A regular meeting of the Specific Tax Implementation Committee was held at the County Courthouse Annex. The meeting was called to order by Chairperson Anderson. Schneider moved to approve the previous meeting's minutes, and with support from Miron, the motion carried unanimously.

A speaker's information packet prepared by Sodergren was distributed to committee members. Sodergren then explained each section. Several suggestions regarding additional material were heard. Potvin suggested including a list of persons contacted by letter to participate in the study committee, plus a copy of the letter, the final list of people appointed, and Hope Trapp's letter with the Board's charge to the committee. It should be stressed that the members represented diverse segments of the population, including the mining industry. Miron thought researching Minnesota news articles for reaction to the raise of tax to \$.45 per ton would be valuable. Potvin wanted a statement on a depletion allowance from the mining industry included in the presentation.

A general discussion ensued concerning questions and topics that might be raised at a presentation.

Anderson led a discussion on strategies. It was felt that since this is a Upper Peninsula-wide problem, it should be shown with concrete examples from Minnesota that a change in the tax does not decrease growth and expansion in the mining industry. It was suggested that an open letter to Senator Mack and Representative Jacobetti regarding their failure to respond to the committee might be published in the Mining Journal. Potvin moved, with Larson supporting, that a letter commending the Mining Journal on Peter Brown's series of articles covering the Specific Tax be sent. Motion passed unanimously. Sodergren moved the committee make an update on their progress to the County Board at the next regular board meeting. Miron seconded the motion, and after discussion, it carried unanimously. A regular meeting of the Specific Tax Implementation Committee was held at the County Courthouse.

On a motion by Larson, with Schneider seconding, the previous meeting's minutes were unanimously approved.

Anderson spoke on the need to convince Senator Mack and Representative Jacobetti to meet with the committee to discuss the revision of the present specific tax. The rough draft of a letter to Jacobetti by May was read. Sodergren and Potvin suggested that the date of the next specific tax meeting be included in the letter. They also wished to get across the point that although the committee desires to meet with Jacobetti as soon as possible, they will proceed with their plans if he does not contact them. Sodergren moved, with Potvin seconding, that the letter be sent to Jacobetti, and a copy attached to the committee's minutes. - Absent: Mr. William Smith (Smith called during the meeting to ask that he be excused)

The first meeting of the Specific Tax Implementation Committee convened at the Northwoods for a dinner meeting.

Prior to any formal discussion, the Committee read a letter sent to the County Board from Representative Jacobetti, stating that he would be unable to meet with the Committee at this time.

A brief and informal discussion was held about the Committee's assignment, after which the Committee proceeded to select a Chairperson.

After some discussion it was moved by Larson, seconded by Sodergren that Anderson be Chairperson, as he is Chairperson of the County Board's committee on Finance and Taxation. There being no other nominations, a unanimous vote was cast for Anderson.

May expressed concern for the necessity of having a member of the Committee act as a coordinator to receive requests for information, speakers, etc. from the public, and assign individual Committee members to fill these requests. It was agreed that it would be valuable to have such a person and that that person should be readily available by phone during the working day for this purpose. May suggested Sodergren for this position. Farrell moved that Sodergren be appointed as Vice Chairperson and Coordinator, seconded by Miron and carried unanimously.

Sodergren stated that he felt the Committee would need one of the Committee members to take on the role of Secretary for the purpose of writing publicity releases, composing copy for brochures, if such are used, and drafting letters. He moved that May be appointed to this position, and it was seconded by Anderson. May stated during discussion that due to time constraints, she could accept this position only if a professional secretary was available to the Committee on a part-time basis to do the clerical work and take minutes.
