

#### Wednesday June 14th 1905, continued.

The special committee on auditing the county books submitted the following report, which was unanimously adopted and the committee discharged.

To the Honorable Board of Supervisors, Marquette County:

Gentlemen--Your committee to whom was referred the matter of auditing the books of the county officers, beg to report that they employed Mr. J. A. Dresser, of Detroit to examine the books of the several officers for the period running from January 1, 1883, to January 1, 1905. Mr. Dresser has submitted detailed reports of his work for this period, which reports have been filed with the county clerk. These show all moneys due and belonging to the county have been accounted for by the several county officers at the time of filing this report except some fines collected but not paid over to the county by certain justices of the peace. Some of these justices have left the county, otherstclaimbthat their books have been lost or destroyed, and it is impossible for your committee to ascertain the amounts of these shortages, but your committee believe such amounts to be small.

Your committee find that a considerable amount of fines collected in cities on complaints made under the several city ordinances for offences which are also punishable under the state law which is payable into the county treasury, there to be distributed as library money among the several cities and townships, has been paid by the several justices of the peace into their respective city treasuries: and your committee recommend that a special committee be appointed to ascertain and report to this board the amount of fines due from the several cities of the county and to adjust all claims they may find to be due the county to the end that such amounts, if any, may be collected and distributed into the library fund of the county, as provided by law.

And your committee further recommend that the county clerk notify all justice of the peace for the county to hereafter pay all such fines to the county treasurer.

Your committee would further report that many of the justices of the peace, who are perfectly honest, retain fines in their hands for a considerable time, much longer than the time provided by law and until long after their bills for services rendered the county have been paid, and in some instances no record is kept of fines collected. We would, therefore, recommend that the prosecuting attorney prepare and furnish to all justices of the peace blank forms

probate of this county mailed a circular letter to the different judges of probate of this state in those counties having a population between 30,000 and 50.000 people. By the census of 1900 this county had a population of approximately 41,000 people. It was thought a fair criterion would be obtained by taking the above list of counties. As an exception to the rule, however, the judge of probate also wrote to Chippewa, Delta, and Menominee counties, for the reason that they are upper peninsula counties, although each have less than 30,000 population. A total of twenty-nine letters were sent and a reply was received from all.

# Thursday September 7th, 1905. Continued.

From such correspondence we find that outside of this county, every county in the State of Michigan which has over 40,000 population has a probate register except one, and that county has a probate clerk whose salary is paid by the county. In other words Marquette County is the onlycounty in this state of over 40,000 population that requires its judge of probate to pay for the clerical work in its probate court.

Of the counties between 30,000 and 40,000 population only three require the judge of probate to pay the entire clerk hire of the probate court. In a very few counties the judge of probate pays part of his clerk hire, and on the other hand some counties employ a stenographer or clerk to assist the register. In the counties of Chippewa, Delta and Menominee, a probate register is provided for the probate court.

While the general practice would seem to justify the county in paying the entire expense of a clerk in the probate court, still your committee thinks best to go slowly upon this matter. In view of the fact that the work in the probate court has been rapidly increasing and will continue to increase as the county grows older, we are of the opinion that the county should add something to the salary of Helen Freeman, the present efficient probate clerk. The judge of probate has voluntarily pledged himself in writing ( which is hereto annexed and made a part of this report ) to pay the present probate clerk twenty-fit five dollars per month as long as she shall continue in said office in addition to any sum voted her by this board. We beleive that this county should do something in addition for Miss Freeman, as she has been in the probate court office nearly five years and as su such clerk she has been faithful, courteous and competent. We therefore recommend that the following resolution be adopted as part of this report:

" Resolved, that the sum of twenty-five dollars per month be and is hereby voted to Helen Freeman as clerk of the probate court. Said salary to begin with Sept. 1, 1905, and to continue until changed by this board."

2. With referance to the claim of Charles Kelsey for reimbursement for clerk hire while judge of probate of this county, this committee beleives that inasmuch as the present judge voluntarily pledges himself to pay to the probate clerk a monthly salary equal to that claimed to have been paid by Mr. Kelsey, it would be unwise to allow said claim. Your committee therefore recommends that this claim be rejected.

No doubt the Board of Supervisors in your County has taken action required by section 2486 of the complied Laws of 1897, relative to the division of the County into representative districts, and they will send to this office for filing a statement showing such divisions, the number of inhabitants in each district, etc.

My object in calling your attention to these requirements was from the fact that some of the counties might overlook the statute referred to, because the legislature in the new act made no change in the apportionment.





Gentlemen: Your committee to whom was referred the communication of the Board of Supervisors, of Menominee County, suggesting that this County, co-operate with it and other counties of the Upper Peninsula in the construction, at some central point, of a workhouse, for the joint use of Menominee, Marquette and other counties associating, to be used for the punishment of drunkards, vagrants and other disorderly persons, by all the counties, beg to report the same back to the board with the following findings and recommendations.

Your committee find that the number of persons heretofore convicted in this County who would naturally be committed to such an institution is not large, and that the persons sentenced to the Marquette County Jail for offences of the character stated are largely employed around the Court House, court house grounds and Jail. Your committee believe that the cost of transporting prisoners to any central point for several counties would alone be more than the county now pays of the entire cost of transportation, board and care of prisoners for offences of such character. Further, the construction of such a workhouse would require an outlay of several thousand dollars and the maintenance of the same would create a fixed charge against this county, which would in the opinion of your committee, be out of proportion to the benefits derived. Your committee therefore recommend that this board do not join in the construction of a workhouse to be used jointly with other counties, as suggested in the communication above mentioned.



gentlemen: - According to instruction, I have examined the books and records in the officers of the county treasurer, county clerk and the criminal dockets of the justices of the peace in the City of Marquette, Negaunee and Ishpeming from Jan.1, 1906 to Jan.1, 1907 and herewith submit my report:

The receipts and disbursements of the county treasurer, and balance of cash on hand as shown in this report are correct and agree with the books and records in the offices of the county treasurer and the county clerk and the monthly and quarterly statements of the auditor general.

I find vouchers for all disbursements from Oct.1,1905,to Jan.1,1907,vouchers for disbursements from Jan.1,to Oct.1,1906 were previously checked by the auditing committee of board of supervisors.

I have checked the monthly and quarterly statements of the auditor general with the county treasurer's books and find the same to be correct. The accounts with the townships and cities have been correctly kept, and having been credited with all tax corrections of the county treasurer and auditor general and debited with the auditors general's refunds and rejected and charged back taxes. They have also been credited with their respective portions of primary school funds, 1 ibrary funds, and liquor taxes. I have examined the circuit court calenders and court journals and find that the fines and costs in criminal cases, amounting to \$1,358.30, and the entry, jury and stenographer fees, amounting to \$241.00, have all been paid to the county treasurer by thee county clerk.

Inhave examined the criminal dockets of Justices Blanchard, Byrne, Crary and Donovan of Marquette: Justices Kronberg, Thoren, Trathennand Verran of negaunee and Justice Andrews of Ishpeming for the year of 1906, and find that the fines collected as shown by the several dockets and papers on file, have all been paid over to the county treasurer.

The dockets of Justice Byrne, Thather, and Verran have not been written up for the past three or four months. Notwithstanding the excuses of ill health, press of business etc. it is unnecessary to mention that they are required by law to have all cases properly enter ed at time of trial and I endeavored to impress them with this fact.

In connection with the rejected and charged back lists would say ,I find that the supervisors have, generally speaking, reassessed these taxes at large, whereby lands on which taxes were rejected because of incorrect, incomplete or indefinite descriptions, have escaped taxation . Care should be taken in order, as far as possible to reassess these descriptions on the lands which are properly liable for same and not spread them at large on the rolls.

In conclusion I desire to mention that the county officers have promptly furnished any information required.


