What particularly impressed me in Merida was the three state institutions-the prison, the asylum for insame and the hospital. We in Michigan have nothing on the state of Yucatan in the matter of state prisons. It is not over-stating it to say that the prison at Merida is a model institution. The cells are nearly twice as large as in our Jackson prison. The sanitary conveniences are up to date in every particular, and the food is wholesome. The warden talked like a man who certainly knows his business. He urged us to speak out our criticisms, if we saw occasion for any, as he was always desirous of receiving suggestions for improving conditions in the prison. They have about 500 convicts, and they are all worked on state account. About 100 make hammocks, which is the regulation bed for all classes. I got one of the best made, and it surely is a fine piece of workmanship. Haggerty got the very best. He thinks it would be a fine thing for his friend, Senator Frank Newton, for a bed on hot summer nights, Frank, you know, is about five feet six inches tall. and weighs around 300. The wide avenue, or boulevard, along the front, together with the well-kept grounds, give the prison buildings an imposing appearance. The prisoners have a brass band.

The hospital comprises twelve buildings for men and twelve for women. All manner of ailments are treated and the equipment and general conveniences are the best and most modern. Dr. Shumway spent several hours examining it, and was very favorably impressed. The insane asylum near by is in keeping with the prison and the hospital. All these institutions were planned and built so as to harmonize in the grouping.

On the advice of the attorney genera and Prosecuting Attorney Bell, the committee is reported to have held that signer has a right to withdraw his name from the petitions before they were 'illed with the county clerk, and 220 names were scratched off the petitions unde this ruling. The committee is said : have found that 2,659 persons had signed the petitions, which is 103 more than onethird of the registered vote of the coun ty, subtracting the withdrawals from which leaves the petitions 117 signatures short of the number required by law. About 200 names, it is reported, were found on the petitions, which do not ap pear on the registration books of the oting precincts in which they reside, but he committee holds that the registration books are not necessarily the criterion by which the legality of the signature should be judged. Supplementary affidavits were filed by Attorney Belden in place of those attached to some of th petitions, in which technical informali ties were found. Attorney Button of jected to the filing of these suppleared ary affidavits, but was overruled. In an address to the committee, A torney Belden stated that he thought was advisable for the committee to recommend the rejection of the petitions inasmuch as the attorney general ha ruled that, in his opinion, most of the withdrawals filed were legal.
