LET US USE MORE ELECTRICITY!

This is not a criticism of the Board of Public Works or any other official. We believe that the members of the Board of Public Works are endeavoring to the extent of their ability to assist in solving the problems that confront us, but we do believe it expedient, to discuss at this time the subject of municipal ownership as far as the city lighting plant is concerned.

- We do this for the purpose of calling attention to the difference between a privately owned plant and a municipal plant.
- When the present plant was purchased by the city for the sum of \$72,000, there were a lot of back taxes on it that the former owners had not paid and havenot paid up to this time.
- There was not muchin the way of machinery, poles, transformers or wires and what there was of it was second hand or antiquated.
- Bonds were issued for the money to pay for the plant, carrying a fair rate of interest, also money appropriated from the public funds to make many, much needed improvements.
 - For years the plant ran behind and the CITY PAID THE BILL.

This shortage which occurred every month for a number of years WAS MADE GOOD FROM TAXES ON TAXABLE PROPERTY AND EVERY PROPERTY OWNER WHO HAD TAXABLE PROPERTY HELPED PAY THE EXPENSE INCURRED BY THE PLANT.

This was all right for the reason that municipal plants must be supported by the municipality if they are not self-supporting.

But municipal plants, under the law are NOT MONEY MAKING CONCERNS and are not supposed to be operated for that purpose. Their function is to furnish to the taxpayers the commodity

AT THE LEAST POSSIBLE COST.

- NOTHING MORE NOTHING LESS.

NOTHING ELSE.

The report is current that there is at the present time a surplus of \$16,000, taken as a profit from those who pay electric light bills and that a portion of this fund is to be used to pay the losses of the gas plant which are predicted to occur in the early stages of its operation.

Who paid the profits that built up this idle surplus?

Wasn't it those who paid taxes without using electric lights as well as those who paid taxes and did use them?

Why should taxpayers who cannot afford electric lights help to create this idle fund and why should those who do use the current be forced to pay an excessive price to create this fund? THE SLIDING SCALE.

Then again why should any taxpayer who has helped to redeem the bonds as well as paying the interest on them be forced to pay a higher rate for his light than another? Both paid the same rate of taxation ontheir property, large or small, to build the plant up while it was running behind and both are still paying the same rate on city, county and state assessments.

If the man who is using a quantity of electricity is en-titled to get it cheaper than the man who uses one light, why is not the same idea carried out on taxable property and the man who owns a lot of property asked to pay less taxes than the man who owns but little? The answer is easy. According to law all men are supposed to be taxed equally.

No individual, firm or corporation contracts for more lights than their actual requirements demand and should pay the same rate as the smaller user:

BOTH OWN EQUAL SHARES IN THE PLANT and municipal plants are operated for the sole purpose of furnishing the inhabitants with lights at the lowest possible cost.

The present contract between the city and the power company is at least a fair one to both and yet every year up to the present time the city has it is alleged, paid money to the power company for current it has not used for the contract says that we must buy so much current a year whether we use it or not.

The city pays a triffe less than two cents per kilowat for the current delivered at thee switchhoard and retails it to the small consumer for eight and ten cents per kilowat. It probably costs as much more for distribution in the city. If it costs more the equipment at the plant should be looked into carefully and some changes made. Even if the current costs the city four cents per kilowat it would be making 100 per cent by selling it for eight cents.

Supposing, however, that the price was made low enough so that everyone could afford to use the lights and the city used all the current that the contract with the power company says it should use, would not everyone be better served?

We believe that the Board of Public Works will look into this matter at once and some ar-
