FRANK H. PETERS DEAD

His Demise Occurred at Newberry Last Sunday.

LEADER IN DEMOCRATIC POLITICS

Was a Former Resident and Other Holder of Schoolcraft County.

Mr. Frank H. Peters died at the home of his parents at Newberry last Sunday noon of a brain affection. Last Autumn he was suddenly stricken with paralysis that deprived him of the power of speech. Later he appeared recovered from this, the blood clot causing the trouble, yielding to treatment. Later there was a recurrence of the trouble and he gradually grew worse until death resulted as stated above.

Mr. Peters' ancestors came to America from England in 1635 and landed in Massachusetts. The subject of this sketch, the son of Mr. and Mrs. Manly B. Peters, was born August 2, 1858 in Putnam county, Illinois, and was educated in the common schools of Michigan and completed his course at the high school of Charlotte. Having an ambition to become a lawyer he entered the law office of Chas. A. Wilby at Reed City in 1883 and in April 1889 he was admitted to the bar at Hareey, Oscoda county before Judge Judkins after a thorough and lengthy examination, and opened a law office at Reed City.

In August 1890 Mr. Peters became a resident of Newberry and at once took front rank as one of the best criminal lawyers of the upper peninsula. He was a resident of Manistique during the greater portion of the past ten years. He was an ardent Democrat and was frequently honored by the party in being its candidate for various positions. He rarely succeeded in the minority but was pretty successful.

Four years ago he was elected prosecuting attorney of Schoolcraft county and was defeated two years later by J. Hixon the present incumbent.

In 1870 Mr. Peters was married to Miss Ella Frances Miller, at Lyons, Iowa, this state. Two children Edna and Frank M. were their issue in this town. Mrs. Peters secured a divorce

from him several years ago. In December 1898 he was married to Miss Nell M. Dams, of Detroit.

Mr. Peters' funeral took place on Monday afternoon at 2 o'clock at his home in an eastward way and was probably the largest funeral ever there.

A PULP MILL IS ALSO ASSURED

Manistique's Future Looks More Bright.

Manistique is paving the way so that the end of the pine industry will be no wise affect the industrial status of the town. While perhaps there is sufficient pine to keep the mills busy for one or two years, an effort is being made to secure new industries which will furnish employment to the citizens of Manistique when lumbering is at an end.

One of the new industries in question is a tannery which has been recently incorporated with a capital of \$200,000.

The branch of the Federal Tannery Co. Its promoters have acquired large tracts of land in the vicinity of Coarise and in other sections tributary to Manistique.

The tannery will be located on the west side of the river south of the Soo Line and M. & N.W. railroad crossing. None of the particulars are obtainable as yet in this writing the representative of the new industry, who reside in Pennsylvania, have not made their appearance.

That Manistique will also have a pulp mill is also an assured fact. We have always contended that the close of the pine era would not sound the death knell of Manistique and the advent of new industries proves this.

Location, the proximity of raw material, water power, facilities for shipping, and a low rate of taxation are some of the inducements that Manistique offers.

May Be a Candidate for Lieut.-Gov.

Hon. S. N. Dutcher of Newberry, was the city this morning and made this office a pleasant one. Mr. Dutcher is being urged to enter the race for the lieutenant governorship, and if he is given sufficient encouragement may go before the next state convention as a candidate.

Work on M. & N. E. Extension. Chief Engineer J. J. Hobbel of the M. & N. E. railroad left the city last Thursday on his way to Manistique after being in the Leelanau county for some time. He says that the road has now 80 men at work on the grade at the right of way from Cedar to Prevention, and that already nearly six of the eleven miles of the extension is graded. The crew of 80 men is quartered in Sullivan's camp, about three miles from Cedar. Another camp is being prepared and an additional crew will be at work in a short time.

Mr. Hobbel assured a Herald reporter that the line to Prevention would be completed this year, and that there is little doubt but that the extension would be pushed on to Northport next year, although he does not think it will go that far this year.—Traverse City Herald.

HON. H. O. YOUNG HERE

His Ambition to Represent the Twelfth District in Congress. Well Received.

IS A FORMIDABLE CANDIDATE

When a young man of twenty-two years of age he came west, locating in Ishpeming in 1872. He was admitted to the bar in 1879 and has since that time been engaged in the practice of law. He formed a copartnership with Geo. W. Hayden in 1884, and for years the firm of Hayden & Young has been one of the most prominent law firms of Marquette county.

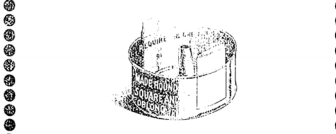
He has always been a stalwart Republican and a prominent advocate of Republican principles. He has been a delegate to every state convention twice since 1870, and for eight years was a member of the state central committee. He has represented his district in the state legislature, has several terms as prosecuting attorney of Marquette, and city attorney of Ishpeming.

Mr. Young is an eloquent speaker and a very pleasant gentleman to meet socially. During his short stay in this city this week he very favorably impressed all that had the pleasure of meeting him.

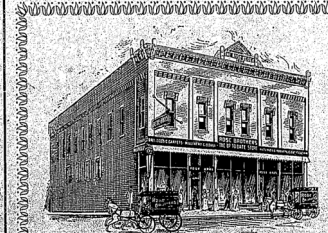

 Venice, May 2.—The imprisoned American naval officers have paid \$2,000 to the parties claiming damages for injury, and the ambassador telegraphed to Rome that all legal impediments to the prisoners' pardon were removed. It is therefore expected that the petition to King Victor Emmanuel for pardon, signed by the officers of the Chicago and forwarded to Rome, will be granted, and that the officers in custody will be released without delay.
 The claimants for damages had telegraphed to the minister of justice, Signor Cocchi-Ottavio, asking him not to object to the petition until their claims were adjusted. This objection has now been removed and the minister here has so notified the minister of justice.

EARLIER NEGOTIATIONS.

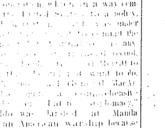
